

## INTERNATIONAL UNDERGRADUATE FINANCIAL CERTIFICATION FORM

Under U.S. Government regulations, any student who will hold F-1 of J-1 status in the U.S. or any student in F-1 or J-1 status transferring from on academic institution to another must provide documentation of the availability of sufficient funding to meet all anticipated expenses.
