Depending on the program qualification, you **may** be eligible for:

- Tuition
- Fees
- Book Stipend
- Monthly housing allowance (MHA)

### WHAT DOCUMENTS DO I NEED?

- DD-214 if applicable (1 time only)
- Certificate of Eligibility (COE)-first time you enroll
- Copy of Academic Grid-each semester
- Copy of Schedule/bill- each semester

## REMEMBER...

- Apply for FAFSA by March 1st of each year at ([www.studentaid.gov](http://www.studentaid.gov)).
- Go to <https://va.gov/> to learn about benefits and apply.
- Contact your RBC SCO (school certifying officer) to present your Certificate of Eligibility and inform of any changes to your schedule including adding, or dropping classes.

## GET QUALIFIED (CONT.)

A GI certification may be submitted as soon as classes are open for registration. All students will be initially certified for 0.00 hours until the official add/drop period ends. Please visit your SCO at the end of the add drop period to make sure your hours are properly reflected for "official certification".

## OTHER FINANCIAL AID

In addition to your VA benefits, you may apply for other federal financial aid by completing the FAFSA for the academic years you plan to attend. The application is free and may supplement your cost of education. You may apply at [www.studentaid.gov](http://www.studentaid.gov)

Federal aid may include grants and loans depending on your submitted information. If there are external scholarships that you are projected to receive, please notify your SCO in the financial aid office. Please ensure that you complete the FAFSA for the intended year of enrollment. The application can be completed starting in October of each academic year. You should list Richard Bland as a school of choice with school code 003707 to ensure that we receive your processed application. If you are selected for a federal process of "verification", you may be contacted for additional information by our verifying partner **Inceptia** and as a result may be required to provide additional information.

## CERTIFICATION AND PAYMENT

Once you have been admitted and have registered, contact your SCO and provide your Certificate of Eligibility (COE) to have your courses certified for the semester to activate benefits. Report any add/drops immediately for adjustment to prevent your indebtedness for overpayment.

## BOOKS

Richard Bland is committed to assisting students to be prepared for the first day of classes. With this in mind, book vouchers are available for qualified students once the semester begins.
