MEMORANDUM OF UNDERSTANDING

Between

VIRGINIA WESLEYAN UNIVERSITY and RICHARD BLAND COLLEGE

This Memorandum of Understanding is made by and between VIRGINIA WESLEYAN UNIVERSITY (VWU) and RICHARD BLAND COLLEGE (RBC).

The terms of the agreement set forth by both parties are set forth as follows:

I. RBC Students Completing A.S. in Business and Certificate in Logistics Management

RBC students who have completed both an A.S. Degree in Business and the Logistics Management Certificate may transfer into VWU, having satisfied the following requirements toward a B.A. Degree in Business and, if pursued, the Supply Chain Management & Logistics Certificate. RBC graduates would be granted the following:

- A. Waiver of the ISP 101 requirement for Business (Logistics IT Applications at RBC),
 - B. Waiver for 3 of the 5 courses required for the VWU certificate,
 - C. Count the 16 RBC certificate credits as fulfilling the 16 credit VWU recommended Business courses, and
 - D. Waiver for 1 of the VWU senior synthesis course requirements (excluding MBE 406), and count the RBC certificate as satisfying the 300/400-level Business component; the remaining synthesis course would need to be non-Business specific.

II. VWU Students Pursuing B.A. in Business and Courses in the RBC Logistics Management Program

VWU students who are Business majors may enroll in courses in Logistics Management Certificate at RBC and complete those courses online (see: http://www.rbc.edu/academics/programs-degree/logistics/). RBC courses in Logistics Management will be listed on the VWU course schedule. VWU students who complete courses through RBC will be granted the following by VWU:

A. Waiver of the VWU ISP 101 course, which is a requirement for the Business major,

- B. Count the RBC Logistics Management Certificate as satisfying the recommended courses for the Business major,
- C. Waiver of 2 of the 5 courses required for the VWU Supply Chain Management & Logistics Certificate, and
- D. Waiver of 1 of the senior synthesis course requirements (excluding MBE 406) and will count the RBC certificate as satisfying the 300/400 level business component; the remaining synthesis course must be in a discipline that is non-Business specific.

Each party reserves the right to change the terms at any time with 60 days written notice. Any such modification will not affect VWU or RBC students who have already enrolled in courses at the other institution.

The agreement between VWU and RBC will remain in effect for a period of five years, at which time it will be reviewed.

Execution of the agreement will begin as of the date first written above.
